What is the overall <u>deductible</u> ?	\$1,500 / individual or \$3,000 / family	Generally, you must pay all of the costs from providers up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible</u> ?	Yes, the deductible doesn't apply to <u>preventive care</u> , and certain services subject to flat dollar <u>copayments</u> .
