MTR LABORATORY TRANSITIONS MICROBIOLOGY TESTING TO McLAREN MEDICAL LABORATORY

The McLaren Thumb Region Laboratory (MTR) has begun transitioning its microbiology specimen testing to the McLaren Medical Laboratory (MML) in Flint. The MML courier arrives twice per a day Monday – Friday and once a day on Saturday and Sunday to take specimens to the MML Lab. Specimen collection requirements, in most cases, will remain the same. Results are available to view in CPSI.

Blood cultures will continue to be processed in house, if they turn positive we will process the specimen gram stain in house and report a preliminary gram stain result. The report will indicate that the culture has turned positive, in what time frame, give the preliminary gram stain result, who results were called to and that the specimen has been sent to MML for further testing. MML uses the BIOFIRE FILMARRAY Blood Culture Identification (BCID) Panel which enables rapid and accurate automated detection of pathogens and antibiotic resistance genes associated with bloodstream infections. These instruments offer a turnaround time of about an hour from receipt of the specimen.

A new blood culture collection kit that is packaged for McLaren Health Care will be available very soon. The new collection kit should assist in reducing contamination rates and help maintain the Quality Metrix for blood culture contamination rates of <2%.

We will also be rolling out a new urine collection cup that will allow for urines to be preserved and if a culture is needed, will assist in reducing the contamination rate of urine specimens.

McLAREN THUMB REGION WOUND & HYPERBARIC CENTER CELEBRATES NATIONAL RECOGNITION

The McLaren Thumb Region Wound & Hyperbaric Center was recognized with a National Award for Excellence in Wound Healing for a third year in a row! The center achieved this award for its healing outcomes, high patient satisfaction rates and outstanding clinical performance. To receive this award, the center must have met a healing rate greater than or equal to 92%, a patient satisfaction rate greater than or equal to 92% and an outlier rate less than or equal to 16% with 28 days or less to heal. The center also had to score in the top 10% of eligible centers. The wound center scored 98% on its healing rate, 96.64% on patient satisfaction and had a patient outlier rate was 10.6% with 21 median days to heal.

The wound center was awarded this prestigious honor by Healogics, the nation's largest provider of advanced wound care services. The award is



named for Dr. Robert A. Warriner III, a pioneer in would care and the former Chief Medical Officer for Healogics. In addition to receiving the Center of Excellence in Wound Healing award, the center has also received the Center of Distinction award in years 2015, 2016 and 2017.

The McLaren Thumb Region Wound & Hyperbaric Center opened in June, 2014. Since opening, the center has treated and healed 1, 275 patients. Providers for the center include Medical Director Avelina Oxholm, MD; Clinical

Program Director Angie Weidman, BSN, RN; Angela Stoutenburg, DPM and Martha Koglin, PA-C. Center staff include Jennifer Anderson, Certified HBO Tech, Cynthia Lynch, RN/Case Manager, Linda Shisler, RN/Case Manager, Sheila Schafer and Caleigh Rasmussen, front office staff.

The Wound Center staff was thrilled to hear the great news of earning this award again and is honored that patients count on the center and staff for their wound healing needs and care.

COMPLIANCE CORNER

When Should You Call Your Compliance Officer

When you inadvertently commit a HIPAA violation and need to self-report. For example:

- Hand discharge papers to the wrong patient.
- Fax patient information to the wrong fax number.
- Hand medications to the wrong patient and they leave the building with them.
- Document in the wrong patient medical record.

When you witness or overhear a blatant disregard for any of the HIPAA rules. For example:

- A fellow employee, physician, vendor or other person is on a hospital computer viewing their own medical record, the record of a family member or friend, or another patient, without a work-related reason.
- An employee or physician is discussing patient information outside of their work area or nursing unit, especially if it concerns a Behavioral Health patient.
- An employee or physician hands

- a patient papers/reports with the wrong patient name, but doesn't report the error.
- An employee faxes patient information to the wrong fax number, but doesn't report the error.
- An employee, physician, vendor or other person is using their own personal cell phone to text patient information to another person when not authorized to use their cell phone.
- An employee, physician, vendor or other person is using their own personal cell phone to take photos of a patient without proper authorization.
- Any employee or physician other person related to McLaren that has posted patient information on a social media site without the patient's express authorization.
 Remember, a name is not the only patient identifier.

When you witness or overhear potential fraud and abuse violations. For example:

 When you see an employee, physician, vendor or other person taking hospital supplies or using hospital facilities for their own

- personal use or in an unauthorized manner.
- When you believe a fellow employee or physician has documented in a chart yet they did not provide the care or has performed a procedure or service that is not medically necessary or warranted.
- When you believe a fellow employee, physician or vendor has entered charges inaccurately.
- When you have gone to your direct report with a Compliance or HIPAA issue but do not feel you were heard or that there has been resolution.
- When you have reported a Compliance or HIPAA issue in good faith but feel retaliated against.

IT'S TICK SEASON

Now that the warmer weather has finally arrived, it is safe to say that individuals are spending more time outside. The more time someone is outside the more likely he/she may come in contact with a tick. Because it is tick season in Michigan, it is important to become knowledgeable about ticks and to be able to identify them in an effort to keep yourself and your family safe from the illnesses ticks spread.

Although ticks can spread multiple illnesses, Lyme disease is the most commonly reported tick-borne disease in Michigan. Lyme disease is caused by the bacterium Borrelia burgdorferi and is transmitted by the blacklegged/deer tick. The blacklegged tick is well-established in Michigan's western Upper and Lower Peninsulas. However, it is expanding into new areas across the Lower Peninsula. Local risk for Lyme disease varies depending on

whether infected ticks are in the area. Several local and state agencies partner to conduct surveillance for Lyme disease in people and animals.

In an effort to protect yourself from ticks do the following:

Avoid tick-infested areas.

- Walk in the center of trails to avoid contact with overgrown grass, brush and leaf litter at trail edges.
- Protect your pets too! Dogs and cats can come into contact with ticks outdoors and bring them into the home, so using tick prevention products on pets is also recommended.

Use insect repellent.

- Apply repellent containing DEET (20-30 percent) or Picaridin on exposed skin.
- Treat clothes (especially pants, socks and shoes) with permethrin, which kills ticks on contact or buy clothes that are pre-treated. Do not

use permethrin directly on skin.

 Always follow the manufacturer's instructions when applying repellents.

Perform daily tick checks.

- Always check for ticks on yourself and your animals after being outdoors, even in your own yard.
- Inspect all body surfaces carefully and remove attached ticks with tweezers.
- To remove a tick, grasp the tick firmly and as closely to the skin as possible. With a steady motion, pull the tick's body away from the skin. Cleanse the area with an antiseptic.

Bathe or shower.

- Bathe or shower as soon as possible after coming indoors (preferably within two hours) to wash off and more easily find ticks that are crawling on you.
- Washing clothing in hot water and drying on high heat will kill ticks in clothing.
- Michigan citizens can submit ticks to MDHHS for identification and possible Lyme disease testing, free of charge.

Tick Identification and Testing in Michigan

Ticks may carry diseases that cause illness in humans and animals in Michigan. Therefore, if you find a tick feeding on a person or a domestic animal, you may want it:

- a) Identified to determine if there is a risk of tick-borne illness
- b) Screened for the presence of disease causing organisms

Michigan's five most common ticks can be <u>seen here</u>. Not all ticks or tick species carry disease agents. The Michigan Department of Health and Human Services (MDHHS) provides tick identification at no charge to Michigan citizens. Ticks that are submitted from people that are identified as blacklegged ticks (formerly deer tick) and are alive* will be forwarded to the MDHHS Bureau of Laboratories for Lyme disease screening at no cost. Ticks that are dead when they are received or are from animals (dog, cat, horse, etc.) will not be tested.

Ticks may also be identified electronically by submitting photos. For more information click <u>here</u>.

Tick Submission Kit (Recommended):

As part of an effort to streamline public tick submission and testing, we have developed a kit for submitting ticks to the MDHHS. The kit consists of a screw cap plastic vial, a self-addressed, padded return envelope, a submission form, instructions for submission, and the Ticks and Your Health brochure.

The kit is available at no charge and can be obtained at your <u>local health department</u>. Alternatively, kits may be ordered via the Communicable Disease Division's publication order form.



For prompt tick submission without using the Michigan Tick Submission Kit:

- If the tick is alive*, place it in a small container with a few pieces of fresh grass, or a small piece of paper towel moistened with a drop of water.
- If the tick is dead, place it in a small container like an old medication bottle.
- Print and complete the <u>Tick Identification and Testing Form.</u>
- Send the container with the tick along with the submission form in a padded envelope to the below address:

- On the outside of the envelope write "FRAGILE" or "HANDLE WITH CARE" to help prevent damage to the tick when shipped.
- * The MDHHS cannot guarantee that ticks sent live through the mail will survive.
